

In Memoriam




Ray Boulanger

Ray spent more than 35 years practicing as a financial services lawyer and made a lasting impact on Goodwin, the legal community, and all who had the privilege of knowing him. In addition to his work at the firm, Ray served as a Captain in the Army and Judge Advocate General at the Pentagon. Ray was very proud of his—and his father's—military service and was a strong supporter of the U.S. Armed Forces for his entire life.
