




## THE FUTURE OF AI


2023 was a year that generated a lot of IP-related questions regarding the use of GenAl. In 2024, I expect we'll get court decisions that will provide better guideposts around when GenAl tool creators and users can face liability for models that are trained using third-party IP or content."

Privacy regulation continues to be front and center for Al. This includes a wave of state legislation on automated decision making, enforcement actions by the FTC, and a focus on the Executive Order of the President on mitigating bias and discrimination in algorithms."





We're in the first wave of the Gartner hype cycle for GenAl and there will likely be a reckoning. Winners will emerge for sure; but given that approximately one-third of ventures dollars last year were deployed into Al companies, it's become a very crowded space, very quickly."
