Please also note that foreign private issuers, asset backed issuers, registered investment companies and some other issuers are subject to requirements that in some cases differ significantly from those on which these tables are based.

For example, inflation and the impact of rising interest rates may require disclosure in the Financial Statement Footnotes, MD&amp;A, the Forward-Looking Statement Disclaimer; and Risk Factors.</p>

<p><b>SEC MD&amp;A and Other Financial Disclosure Rules Effective for Companies with December 31 Fiscal Year-End</b></p> <p>The <a href="#">final amendments</a> to MD&amp;A and other financial disclosure rules adopted by the SEC in November 2020 permitted companies to voluntarily provide disclosure consistent with the final amendments at any time after February 10, 2021 on an item-by-item selective basis as long as the company complied with the amended item in its entirety and continued to do so in any applicable filing going forward.</p> <p>A summary of the final amendments can be found in the Goodwin alert <a href="#">SEC Amends MD&amp;A and Other Financial Disclosure Rules</a>. Selected key changes that could affect Form 10-Q filings for the most recent fiscal quarter include:</p> <ul style="list-style-type: none"> <li> <p><b>Interim Period Comparison – MD&amp;A (Part I, Item 2)</b></p> <p><i>Very important: the form check of the Form 10-Q should include review of the required quarterly comparison to confirm that it complies with amended Item 303(c).</i> Item 303(c) now requires a company to discuss changes from <i>either</i> the prior year quarter, as previously required, or the sequentially preceding quarter. <b>If a company compares the current quarter to the sequentially preceding quarter, it must either provide summary financial information for that quarter or identify its prior filings on the SEC’s EDGAR system that present that information.</b> If a company changes from one form of comparison to the other, it must discuss the reasons for the change and provide both comparisons in the first filing in which the change is made.</p> </li> <li> <p><b>Critical Accounting Estimates – MD&amp;A (Part I, Item 2)</b></p> <p>Form 10-Q must include disclosure regarding critical accounting estimates. Contrary to common past practice, this disclosure should not merely repeat the disclosure in the accounting policies section of the financial statement footnotes.</p> </li> <li> <p><b>Contractual Obligations and Off-Balance Sheet Arrangements – MD&amp;A (Part I, Item 2)</b></p> <p>Item 303(c) of Regulation S-K generally requires only discussion of material changes in previous disclosures about items such as contractual obligations and off-balance sheet arrangements. If MD&amp;A contains disclosure that substantially restates the disclosure in the company’s Form 10-K, note that:</p> <ul style="list-style-type: none"> <li>The <b>contractual obligations table</b> has been eliminated. A more flexible principles-based approach to this disclosure has been integrated into the liquidity and capital resources requirements to specifically require disclosure of material cash requirements from known contractual and other obligations. Tabular disclosure can still be used to comply with the new disclosure requirements, but companies have flexibility as to what information to provide in the table.</li> <li>Similarly, there is no longer a requirement to have a separately captioned section for <b>off-balance sheet arrangements</b>. The amended rules integrate broader and more flexible principles-based disclosure about off-balance sheet arrangements into other MD&amp;A sections.</li> </ul> </li> </ul>

<p><b>Russian Sanctions, Russia-Ukraine Conflict and Related Disclosure</b></p> <p>Review MD&amp;A (Part 1, Item 2) and Risk Factors (Part 2, Item 1A) for disclosure about the impact and/or known potential material future effects of ongoing developments in Russian sanctions and the Russia-Ukraine conflict. Disclosure is generally required with respect to the material effects of Russian sanctions and the Russia-Ukraine conflict, if any, on the company. The most likely and generally most important parts of the Form 10-Q to review for this disclosure are Risk Factors (Part II, Item 1A) and MD&amp;A (Part I, Item 2). Areas for potential disclosure include material impacts related to the items listed below.</p> <ul style="list-style-type: none"> <li>• Russian sanctions impacts;</li> <li>• Impacts on business operations in Russia and/or Ukraine;</li> <li>• Russian and/or Ukraine market and revenue impacts;</li> <li>• Commodity/materials/supply chain/energy impacts;</li> <li>• Vendor/supplier impacts;</li> <li>• Outsourcing/staffing impacts;</li> <li>• Clinical trial impacts;</li> <li>• Financial accounting impacts, including (for example) impairment of assets and control/consolidation issues;</li> <li>• Credit and financial market impacts; and</li> <li>• Global economic conditions and uncertainties.</li> </ul> <p>In addition, note that Russian sanctions and the Russia-Ukraine conflict may contribute to several of the factors listed under Inflation and Rising Interest Rates, discussed above, including increased energy costs, supply chain disruptions and operating expense inflation impacts.</p>

<p><b>COVID-19 Pandemic</b></p> <p>Review COVID-19 disclosures and confirm that these disclosures speak as of the date of filing of the Form 10-Q. In particular, review disclosure carried forward from earlier reports for current accuracy. Disclosure topics for potential inclusion include, among others:</p> <ul style="list-style-type: none"> <li>• impact of the Omicron variant, the BA.2 subvariants and other SARS-CoV-2 viruses;</li> <li>• the company's current responses to COVID-19;</li> <li>• discussion of changes in responses by businesses and state and local governmental authorities;</li> <li>• plateaued or stagnant vaccination and booster rates; and</li> <li>• continuing and potential future impacts such as supply chain/distribution constraints, among others.</li> </ul>					
<p><b>Environmental, Social &amp; Governance (ESG) Matters</b></p> <p>ESG disclosures are often taken from the company's ESG and sustainability reports that may be driven more by marketing or investor relations considerations than legal or financial considerations. Although ESG disclosure is less likely in a Form 10-Q than a Form 10-K, it is very important to make sure that any ESG disclosures in the Form 10-Q are appropriate, and appropriately worded, for an SEC filing. This may cause the company to revise or eliminate certain phrases or sentences so they are more aspirational in nature and/or backed up by reliably attributable data. The SEC has been particularly focused on climate change, and on September 22, 2021, the Staff of the Division of Corporation Finance published a <a href="#">sample comment letter</a> on climate change disclosures that you may want to consider in reviewing the 10-Q. On March 21, 2022, the SEC proposed new disclosure requirements on climate-related risks, governance, metrics and financial statement impacts. <p><b><u>ENTERING AND EXITING LARGE ACCELERATED FILER AND ACCELERATED FILER STATUS</u></b></p> <p><b>[See SEC <a href="#">Small Entity Compliance Guide</a> for guidance on transitioning into and out of Smaller Reporting Company (SRC) status.]</b></p> <p><b>Exiting Accelerated Filer Status.</b> Once a company becomes an accelerated filer, it will remain an accelerated filer unless the company determines at the end of a fiscal year that the aggregate worldwide market value of the voting and non-voting common equity held by non-affiliates of the company was less than <b>\$60 million</b> as of the last business day of the company's most recently completed second fiscal quarter. A company making this determination becomes a non-accelerated filer. The company will not become an accelerated filer again unless it subsequently meets the conditions for accelerated filer status under SEC rules.</p> <p><b>Exiting Large Accelerated Filer Status.</b> Once a company becomes a large accelerated filer, it will remain a large accelerated filer unless the company determines at the end of a fiscal year that the aggregate worldwide market value of the voting and non-voting common equity held by non-affiliates of the company was less than <b>\$560 million</b> as of the last business day of the company's most recently completed second fiscal quarter. If the company's aggregate worldwide market value was \$60 million or more, but less than \$560 million, as of the last business day of the company's most recently completed second fiscal quarter, the company will be an accelerated filer. If the company's aggregate worldwide market value was less than \$60 million, as of the last business day of the company's most recently completed second fiscal quarter, the company will be a non-accelerated filer. The company will not become a large accelerated filer again unless it subsequently meets the conditions for large accelerated filer status under SEC rules.</p> <p><b>How Change of Status Affects Filing Deadlines: Acceleration of Deadlines.</b> The determination at the end of a company's fiscal year for whether a non-accelerated filer becomes an accelerated filer, or whether a non-accelerated filer or accelerated filer becomes a large accelerated filer, governs the deadlines for the annual report to be filed for that fiscal year, the quarterly and annual reports to be filed for the subsequent fiscal year and all annual and quarterly reports to be filed thereafter while the company remains an accelerated filer or large accelerated filer. A company that no longer qualifies as a smaller reporting company as of the last day of its second fiscal quarter may continue to use the scaled disclosures permitted for a smaller reporting company through its annual report on Form 10-K for that year, and then begin providing non-scaled larger company disclosure in the first Form 10-Q of the next fiscal year. However, the <b>due date</b> for the company's Form 10-K annual report will be based on the company's filing status as of the last day of the fiscal year.</p> <p><b>How Change of Status Affects Filing Deadlines: Deceleration of Deadlines.</b> The determination at the end of the company's fiscal year for whether an accelerated filer becomes a non-accelerated filer, or a large accelerated filer becomes an accelerated filer or a non-accelerated filer, governs the deadlines for the annual report to be filed for that fiscal year, the quarterly and annual reports to be filed for the subsequent fiscal year and all annual and quarterly reports to be filed thereafter while the company remains an accelerated filer or non-accelerated filer.</p>
